# PERRY COUNTY COUNCIL MINUTES –November 21, 2017

The Perry County Council met on the above date at 4:30 p.m. as was duly advertised. County Council members in attendance were: Vice-President Jody French, Danny Bolin, John J. Taylor, and David Etienne. Steve Goodson, Thomas Hauser, and J.R. Flynn were not in attendance. A media representative from the <u>Perry County News</u> was present and also Council Attorney, James G. Tyler.

The meeting opened with the Pledge of Allegiance.

### **APPROVAL OF MINUTES**

The minutes from the meeting of September 6, 2017, September 11 and 12, 2017, and September 21, 2017 had been mailed to council members for their review. John made the motion to approve the minutes as presented and David seconded the motion. Motion carried 4-0.

#### **TRANSFERS**

Judge Lucy Goffinet requested a transfer from Travel to Office Supplies in the amount of \$400.00 within the Circuit Court Budget out of County General. David made the motion to approve the request, seconded by Danny. Motion carried 4-0.

Park and Recreation Director Greg Hendershot requested the following transfers with in the Park and Recreation Budget. He requested \$100.00 from Janitorial Supplies, \$90.00 from Subscriptions & Dues, \$7.00 from Postage, \$200.00 from Travel, \$200.00 from Park Maintenance, and \$300.00 from Recreation Program to Tools in the amount of \$97.00, to Fuel and Lubricant in the amount of \$200.00, to Equipment Repairs in the amount of \$100.00 and to Equipment in the amount of \$500.00, all within the County General fund. David made the motion to allow the request, second made by Danny. Motion carried 4-0.

The Commissioners requested a transfer of \$1,300.00 from ADA Transitional Plan, \$500.00 from Codification of Ordinances, \$600.00 from Internet, and \$1,000.00 from Mechanical Maintenance Agreement, totaling \$3,400.00 to Computer System Maintenance within the Cumulative Capital Development fund under the Courthouse Budget. They also requested \$3,015.00 from Building Maintenance to Janitorial Equipment from Cumulative Capital Development fund. Danny made the motion to approve the transfer, seconded by John.
