PERRY COUNTY COUNCIL MINUTES – FEBRUARY 23, 2017

The Perry County Council met on the above date at 4:30 p.m. as was duly advertised. Council members in attendance were: Jody French, Danny Bolin, J.R. Flynn, John Taylor, Tom Hauser and David Etienne. Steve Goodson was absent. A media representative from the *Perry County News* was also present, along with Council Attorney Jim Tyler.

The meeting opened with the Pledge of Allegiance.

APPROVAL OF MINUTES

The minutes from the meeting on January 26, 2017 had been mailed to council members for their review. Danny made the motion to approve the minutes as presented, second made by J.R. Flynn. Motion carried 6-0.

TRANSFERS

Assessor Mendy Lassaline requested a transfer of \$16,532.00 from Second Deputy Salary to Part Time Deputy within the County General fund. She explained to the Council that since budget time last year, she had an opening in her office. She looked into it and decided to change this position to part time with 28 hours per week with no benefits. Commissioner Randy Kleaving spoke up saying the Courthouse Security Committee approached Mendy before filling this opening she had. By filling this position with part time employment, it will save more money in County General to hopefully get employees to man a metal detector placed in the entrance in the future. Jody commented saying these are things that need to be looked at budget time along with other funds. Tom made the motion to allow the transfer, seconded by Danny. Motion carried 6-0.

Highway Superintendent, Steve Howell, requested a transfer in the amount of \$7,000.00 from Salt to New Road Equipment within the Motor Vehicle Highway fund. Steve said there is extra appropriation in the Salt account because of the weather this winter. This money is to buy attachments for their bobcat to work on bridges. David made the motion to approve the transfer, second made by JR. Motion carried 6-0.

The Commissioners are requesting a transfer of funds from the CEDIT Distribution to TIF Allocation fund in the amount of \$110,000.00 for temporary extra funds for the renovation of the Armory Annex. The Commissioners approved an amendment to the EDIT plan for this and it will be repaid to the TIF Allocation fund with incoming property tax dollars. Danny made the motion to approve the transfer, seconded by Tom. Motion carried 6-0.

ADDITIONAL APPROPRIATIONS

Highway Superintendent, Steve Howell, requested an additional appropriation in the amount of \$783,924.65 for County Road Improvements from the LIT- Economic Development fund. This is using the Highway's 50% of the EDIT money plus their half from last year to put up for the Community Crossings Grant. The Council gave a motion of intent for this request at their January meeting. JR made the motion to approve the request, seconded by Tom. Motion carried 6-0.

Steve Howell, Highway Superintendent, request an additional appropriation from the Cumulative Bridge fund for Bridge #148 on County Road #167 in the amount of \$47,500.00. Steve commented that the Council gave a motion of intent for this request also at their January meeting. John made the motion to approve the additional, second made by Danny. Motion carried 6-0.

Highway Superintendent, Steve Howell, also requested an additional appropriation from the Motor Vehicle Highway fund in the amount of \$24,937.00 for raises and benefits for the highway employees. The request was for: \$1,406.00 for Superintendent Salary, \$2,274.00 for Foreman Salary, \$1,040.00 for Office Manager Salary, \$3,620.00 for Truck Drivers Salary, \$13,344.00 for Operators Salary, \$2,047.00 for Mechanic Salary, \$780.00 for Social Security, and \$426.00 for Retirement. Jody spoke up saying that Steve would like to be here for this vote and to form a committee to go over salaries and make a plan going forward on these raises. There was discussion among the Council. Tom and JR both spoke up saying they thought this was already talked about and done. Tom made the motion to approve the additional request, seconded by JR. Motion carried 6-0. It is retroactive to January 1, 2017.

Steve Hauser, EMA Director, requested an additional appropriation in the amount of \$7,685.00 for salary increase and PSAP GIS Mapping from the Statewide 911 budget. Steve commented that this salary increase will bring the total salary for the Administrative Assistant to a First Deputy pay. She has 28 years experience and this increase for Part Time Data Entry is part of her job description. John made the motion to approve the additional, seconded by Danny. Motion carried 6-0. It is retroactive to January 1, 2017.

SALARY ORDINANCE ADMENDMENTS

Auditor Pam Goffinet informed the Council since they approved the salary change and increases, they need now to approve the amendments to the salary ordinance that was approved at budget time last year. They are as follows: Assessor – Part Time Deputy at \$12.30 per hour; Highway – Superintendent at \$48,240.00/1,855.38 biweekly, Formen (2) at \$39,007.00/\$1,500.26 biweekly, Office Manager/Administrator - \$33,426/\$1285.61 biweekly, Truck Drivers at \$15.99 per hour, Operators at \$17.07 per hour, and Mechanic (2) at \$18.03 per hour; Statewide 911 – Data Entry at \$2,896.00/\$111.38 biweekly. John made the motion to approve the amendments to the salary ordinance, second made by Danny. Motion carried 6-0.

TEMPORARY ADVANCE

Pam Goffinet, Auditor, requested a temporary advance in the amount of \$300,000.00 from Debt Service-Detention Center to County General fund, \$50,000.00 to Health fund and \$100,000.00 to Cumulative Capital Development fund. She explained that the advance will be paid back when tax dollars are distributed. Danny made the motion to approve the Temporary Advance and John seconded the motion. Motion carried 6-0.

TRANSFER FOR TEMPORARY ADVANCE ORDINANCE

CC-17-1

WHEREAS, IT HAS BEEN DETERMINED THAT IT MAY BE NECESSARY TO TEMPORARILY ADVANCE MONEY FROM MAJOR FUNDS WHOSE REVENUES ARE DERIVED FROM THE LEVYING AND COLLECTION OF TAXES ON PROPERTY, THE LEVYING AND COLLECTION OF SPECIAL TAXES, AND FROM OTHER REVENUE DERIVED FROM ANY OPERATION OF THE COUNTY IN ACCORDANCE WITH 36-1-8-4.

MOTION OF INTENT – HIGHWAY BRIDGE #99

Highway Superintendent, Steve Howell, requested a motion of intent for an additional appropriation on Bridge #99 County Road #201 in the amount of \$49,250.00. She commented that they have no set meetings.

Steve Howell, Highway Superintendent informed the Council that the Highway workers have put metal siding on the Salt building and have updated the lighting inside and outside of the multipurpose building. They will receive around \$950.00 reimbursement from Southern Indiana Power.

There being no further business to come before the council, John made the motion to adjourn the meeting, and David seconded the motion. The motion carried 6-0, with adjournment at 5:00 p.m.
