COMMUNITY WELLNESS COORDINATOR

Cathy Boerste, Perry County Extension Agent, introduced Erin Meyers as the new Community Wellness Coordinator. This new position will give the County additional services with no extra funding. It is totally grant funded. Ms. Meyers will be over Perry, Spencer, Crawford and Orange counties.

TAX ABATEMENTS

Council Attorney, Jim Tyler, informed the Council about the change in process on certifying the County's tax abatements for taxes 2017 pay 2018 with the filing of the CF-1's. Starting this year and annually afterwards, the abated company is to file a CF-1 with the corresponding entity for which they filed a certified SB-1 on. The CF-1's have to be filed by May 15th or by extension if granted of each year to stay in compliant with their original abatement filed.

He told the Council that he had met with Auditor Pam Goffinet and Deputy Auditor Connie Berger earlier in the day and reviewed all the CF-1's filed for the County which is: Indiana Municipal Power Agency Personal Property and Real and Personal Property of ATTC. He commented saying they were in compliant as to filing their CF-1's on time. He also said he felt they appeared to all be compliant when comparing their SB-1's to the CF-1's. They have over achieved on salaries and employees. Jim informed the Council that they need to vote on each abatement separately.

- 1. Indiana Municipal Power Agency PP install 1MW photovoltaic solar generation panels and related equipment. Tom made the motion to approve the CF-1, seconded by Danny. Motion carried 6-0.
- 2. ATTC Real Property 74,277 sq. ft., new manufacturing space connected to existing building. J.R. made the motion to approve the CF-1, second made by John. Motion carried 6-0.
- 3. ATTC- Real Property 2730 sq. ft. expansion of existing FG warehouse. This expansion will include the relocation of existing shipping office and bathroom in the new addition. J.R. made the motion to approve the CF-1, seconded by David. Motion carried 6-0.
- 4. ATTC Real Property 1524 sq. ft. break/meeting room addition to be constructed on the west side of existing building. Danny made the motion to approve the CF-1, second made by John. Motion carried 6-0.
- 5. ATTC Real Property 9667 sq. ft. Multi-Purpose addition, plans to install new training facility, a multi-purpose hall, gym and some meeting rooms. John made the motion to approve the CF-1, seconded by J.R. Motion carried 6-0
- 6. ATTC PP 1 new front rotor machine line including tooling and various other manufacturing equipment \$1,000,000. John made the motion to approve the CF-1, seconded by Danny. Motion carried 6-0.
- 7. ATTC PP 1 new rear carrier machine line including tooling and various other manufacturing equipment \$1,000,000. Tom made the motion to approve the CF-1, second made by J.R. Motion carried 6-0.
- 8. ATTC PP 1 rear rotor machine line/cell including tooling and various other manufacturing equipment \$2,000,000. Danny made the motion to approve the CF-1, seconded by John. Motion carried 6-0.
- 9. ATTC PP Flexible machining system (FMS-3) including tooling and various other manufacturing equipment \$750,000. J.R. made the motion to approve the CF-1, seconded by David. Motion carried 6-0.
- 10. ATTC- PP- 4 differential case manufacturing cells including tooling and various other manufacturing equipment \$7,000,000. John made the motion to approve the CF-1, seconded by Danny. Motion carried 6-0.
- 11. ATTC- PP 4 differential case machining cells including tooling and various other manufacturing equipment \$10,000,000. J.R. made the motion to approve the CF-1, second made by John. Motion carried 6-0.
- 12. ATTC PP- 2 differential case machining cells including tooling and various other manufacturing equipment \$5,500,000. John made the motion to approve the CF-1, second made by Danny. Motion carried 6-0.
- 13. ATTC PP SB -1 filed in 2005. J.R. made the motion to approve the CF-1, seconded by John. Motion carried 6-0.
- 14. ATTC PP 20 new machining lines \$30.5 million. J.R. made the motion to approve the CF -1, seconded by David. Motion carried 6-0.

Auditor Pam Goffinet commented saying that two of these abatements are down to the last 10% allowable and 2017 pay 2018 will be the last year for this reduction. Attorney Jim Tyler informed them that there will possibly be two more ATTC abatements to come before them in July but they need to be investigated more.

MISCELLANEOUS

Auditor Pam Goffinet reminded the Council about their Council State Called meeting that is this coming Saturday, June 24, 2017 if anyone planned on attending. She also mentioned to the Council about the upcoming budget dates that had been sent to each of them. If there was any conflict, they are to let her know as soon as possible.

There being no further business, Danny made a motion to adjourn the meeting. John seconded the motion. Motion carried 6-0, with adjournment at 5:05 p.m.
