PERRY COUNTY COUNCIL MINUTES August 24, 2017

The Perry County Council met on the above date at 4:30 p.m. as was duly advertised. Council members in attendance were: President Steve Goodson, John Taylor, Jody French, Danny Bolin, J.R. Flynn, David Etienne, and Tom Hauser. A media representative from the <u>Perry County News</u> and Attorney James Tyler were in attendance also.

The meeting opened with the Pledge of Allegiance.

SHERIFF PENSION

Stan Brown, One America, and Elaine Beatty, Morgan Stanley, appeared before the County Council to discuss a Sheriff Pension for our Sheriff Merit Employees. Elaine stated that 91 of the 92 counties do have some type of benefit system. Elaine commented saying things are different now than when the plan was first enacted around the state. We have drugs, violence, terrorism and etc. now. Having a pension plan is a way to get qualified employees and also to keep them. The nature of the job that the deputies do affects not only them but their families also. In 1989, we were 1 out of 6 that did not go on the pension plan when it was offered.

There are 3 different plans, 20 year, 26 year and 32 year. All Council members were given an actuarial study that spells out the plan and different options available. The majority of the counties in the state are at the 26 year plan. This is a county option; there is no mandate from the state on not having a separate pension plan.

There was discussion on funding a pension plan. Right now, the Sheriff and deputies County Share of Perf is appropriated. Based on 2017 figures, it is \$44,126.54. The Clerk collects a Sheriff's service fee that goes to County General now, but if a plan is in place it will go to the Sheriff Pension plan according to state law. That is around \$12,000. The fees on this have increased as of July 1, 2017 from \$25.00 to \$28.00. Also, there is \$859.00 life insurance that we would remove from our current carrier because the new pension plan offers a life insurance to the deputies and sheriff. In the Public Safety-County Share budget, the Council has budgeted \$30,000 already for a Sheriff Pension plan. So the only new money to appropriate is with a minimum amount for a 20 year plan - \$3,019.00, 26 year plan - \$11,006.00, and 32 year plan - \$12,939.00. The Sheriff and deputies have agreed to help also by increasing their contribution by 1% each paycheck from 3% to 4% based on their salaries.

One question asked is there a charge for an annual study for amount to be budgeted for the next year. Stan replied saying there is and it can be paid from the plan.

Stan commented saying the Council is always a part of the decision making when any amendments are done to the plan. He said by implementing one of the plans, you are doing this for the retention of your employees.

The Council said they would review the plans. They thanked Stan and Elaine for coming to the meeting to explain the pension plan.

<u>REVIEW OF TAX LEVIES & CIRCUIT BREAKER CREDITS – NON BINDING</u> UNITS

Copies of the Estimated Maximum Levy for Budget Year 2018 and the 2018 Estimated Property Tax Cap Impact Report had been mailed to each Council member for their review. According to IC 6-1.1-17-3.6, at their first meeting in August, the County Council is to review these documents and either make recommendations, or not, to the taxing units about any changes. The taxing units include the seven townships, three school corporations, three cities and towns, and the public library. The votes are:

Auditor Pam Goffinet will send notice to the units of the Council's decision.

TRANSFERS

Perry County Sheriff, Alan Malone, requested a transfer within the Sheriff department from Official Records to Part Time Police Officer in the amount of \$300.00 within the County General Fund.

Perry County Commissioners requested a transfer within LIT Public Safety-County Share in the amount of \$4,800.00 from Ambulance Service to Ambulance Engine Repair.

Jody. made the motion to approve all the transfer requests, seconded by J.R. Motion carried 7-0.

Commissioner Randy Kleaving spoke up saying that the Commissioners have been working with the EMS to bump up the cycle of ambulances instead of getting one every 3 years. He commented saying that for 2018 they have put in the LIT Public Safety-County Share budget for an emergency vehicle (ambulance). They are asking the Council for a motion of intent to go ahead and approve the request in the 2018 budget before they meet in September so they can purchase a demo ambulance they are looking at. Randy said the cost is \$149,500 for the truck and box only. It will be put on a 3 year lease with first payment in 2018. The equipment needed is planned to be paid from this year's subsidy in the Ambulance Service line item. Jody made the motion of intent to purchase the demo ambulance, second made by John. Motion carried 7-0.

MISCELLANEOUS

Dr. William Marcum, President of the Sheriff Merit Board, spoke up saying how he was in support of the new Sheriff Pension plan for the Sheriff and the deputies. After listening to the information, he would love to see the 32 year plan for them, but would like the 26 year plan. He asked the Council to support this and not take a chance to lose any deputies. He would like to hold on to the employees we have.

There were several interested individuals in the crowd wanting the Council to consider funding an Animal Control Officer for the County. They say there are people interested in the job. They need someone to transport the animals to the shelter. Jim Carter commented saying that there was a Comp plan done in 2015 with County Codes and Ordinances to abide by. He says it is not being followed on hiring an Animal Control Officer. He also commented saying for the past 5 years there has been zero funding for the officer. He told the Council it is time to seriously consider funding this position. He said you always find the money when needed for other things.

Several other concerned citizens talked about how they are worried about the animals in the cities and around their own homes. They just want the Council to help.

Steve asked the Finance Committee if they had anything to report at this time. They said they plan on meeting again and comparing their information.

There being no further business, Jody made a motion to adjourn the meeting. Danny seconded the motion. Motion carried 7-0, with adjournment at 6:05 p.m.
